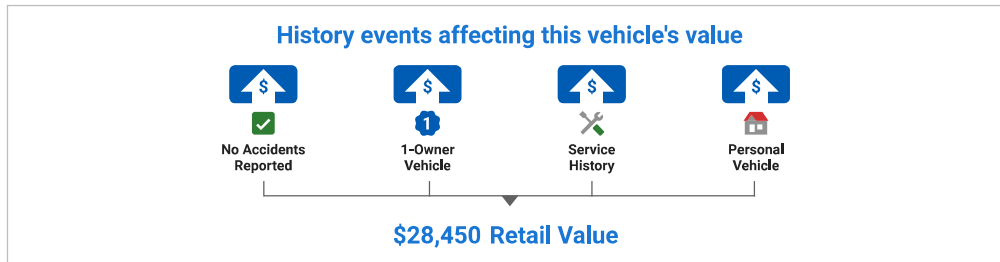

Ownership History
